# Proposed Updates to Saanich's Pesticide Bylaw

Fact Sheet

Saanich Council adopted the Pesticide Bylaw in 2010 to reduce pesticide use in residential lawns and gardens.

The provincial government amended their Integrated Pest Management Act (IPMA) in 2015 after six years of consultation. Saanich has the opportunity to update our bylaw too so residents can have more options.

The following pesticides can now be added to Saanich's bylaw to allow residents to use without a Pesticide Permit or hiring a professional:

# Proposed Updates to Saanich's Pesticide Bylaw

## WHAT ARE HOUSEKEEPING AMENDMENTS?

After eight years of implementing the Pesticide Bylaw, additional "housekeeping amendments" are proposed. These are changes needed to clarify, tidy, correct, format, and update information. For the Pesticide Bylaw, they include:

- Adding a definition of 'serious economic loss';
- Adding a definition of 'Manager of Environmental Services' in order to include a delegate;
- Clarifying that an applicator of pesticides must be certified and follow the principles of Integrated Pest Management as stated in Appendix 1 of the bylaw;
- Expanding pesticide permit applications to be made for multiple properties or owners; and
- Appending an updated format for the Pesticide Permit Application (Appendix 1 of the bylaw).

### CAN WE ASK FOR MORE CHANGES?

In the future, if there is direction from Council and subsequent public engagement, some additional amendments to consider are:

- Addressing pesticide use in the residential areas of institutional, commercial, and industrial properties;
- Increasing opportunities for residents to use glyphosate as per the updated IPMA;
- Allowing residents to apply domestic products if they obtain a Residential Applicator Certificate as per the updated IPMA;
- Addressing neonicotinoids, which are harmful to bees; and
- Other issues brought forward by residents.
