Fire and Police Services – Work is underway on a number of 2015 projects including increased municipal emergency management capabilities and moving to Industry Canada's dedicated public safety radio frequencies.



Effective use of social media and website technologies to engage the community and allow for sharing and dissemination of vital information in the face of a major emergency is a high priority. As part of this multi-year project, an Emergency Information Response Plan is under development.

Working in collaboration with Capital Region Emergency Services Telecom (CREST), a safe and effective transition to a Project 25 standard technology platform for emergency communications will support our Fire and Police services and all dispatch clients.

Providing Quality Drinking Water – The Rithet Reservoir supplies water to Broadmead, Blenkinsop Valley, Cordova Bay and part of Gordon Head and is one of the key elements of the Saanich

water supply system. The new reservoir is designed to be integrated into the surrounding landscape, with features such as partial burial of the building, installation of green walls and the planting of native species.

# A Message from Saanich Council

Your 2015 property tax notice is enclosed. Each homeowner's change in taxation varies due to property tax assessments. If the change to the assessment of your home was the same as the average change for homes in Saanich, then your general municipal tax increase will be 2.21% for core operations, 0.58% for resource requests to maintain current service levels, 1.32% for capital replacement and 0.12% for new infrastructure maintenance and additional operating costs (\$93.57 for the average home assessed at \$592,500).

In addition to municipal levies, taxes are collected on behalf of other taxing authorities, who generate their own calculations to determine taxes to be collected by Saanich. For 2015, taxes collected on behalf of these various authorities represent 41% of your total property tax amount. The chart above provides the details of amounts collected on behalf of each agency.

# What You Told Us You Wanted – Projects to Watch in 2015

In January 2015, Saanich sought community feedback through citizen and business surveys. Top spending priorities for capital projects included water, sewer and drain infrastructure; environmental protection and enhancement; street, bike lane and sidewalk infrastructure. The highest rated municipal services included parks and recreation, fire and police services, and the provision of quality drinking water.

### Integrating the Top Spending Priorities – Constructing Complete Streets

The use of the Complete Streets philosophy is an important milestone for Saanich in the evolution of design for major roads. The philosophy recognizes and accommodates all mobility options in a safe environment, seeks to include environmental enhancements, and acknowledges the importance of streets

The Cook Street Project will be a wrap in 2015 and will meet the needs of motorists, cyclists and pedestrians of all ages for many years to come. The project will help reduce greenhouse gas emissions, enhance the urban forest, and improve stormwater quality.

The Tillicum Road Project is now underway, beginning with the installation of new underground utilities, and including new and upgraded sidewalks, buffered or separated bike lanes, storm water management, the planting of over 75 new trees, and numerous traffic safety improvements.

### Highest Rated Municipal Services – Leading the Way

Parks and Recreation – The Older Adult and Youth Development Strategies, and protecting Panama Flats for future generations are three projects being undertaken in 2015.

> The Older Adult Strategy will have an emphasis on healthy, active and engaged aging which strengthens the overall community, lowers health costs and supports older adults staving in their homes. The Youth Development Strategy will create and maintain connections with the youth community, strengthen ties with other service providers and set the stage for programs and services that will engage youth over the next five years.



With the Panama Flats concept plan approved in 2014, Saanich awaits the decision to include 14.5 hectares at Panama Flats in the Agricultural Land Reserve. Next steps include finalizing the drainage plan and seeking expressions of interest for agricultural uses of the land. Panama Flats will ultimately support local food production, better manage storm water in the area, maintain wildlife habitat, and improve recreational trail access.
