- 18 years of age or older on general voting date (Saturday, October 20, 2018);
- Resident of British Columbia for at least six months immediately preceding the day nomination papers are filed; and
- Not disqualified under any enactment from being nominated for, being elected to or holding office, or to be otherwise disqualified by law.
- A person or the commander of an armed forces unit who has been granted freedom of the municipality, if that person is a Canadian citizen (for Saanich Municipal Council offices only).
