- The final increase brings Saanich to the sustainable funding level that needs to be expended annually.
- The Capital Regional District's debt servicing for the Leech River Watershed will be refinanced in 2018 and a new borrowing rate will be established at that time.
- It is challenging and inadvisable to predict future debt servicing rates.

Councillor Plant stated:

- In the next round of budgeting, Council should re-affirm the water rates to maintain sustainable funding levels.

Report of the Acting Director of Engineering dated October 29, 2014 recommending Council award Request for Proposal 35/14 for cab and chassis complete with aerial device and service body to Commercial Truck Equipment Co. in the amount of \$229,603.00 (excluding taxes).

- The truck being replaced is one of two bucket trucks that the electrical section uses for traffic signal and street light maintenance; both are 20 years old but the truck being replaced has had considerably more use.
- The unit being replaced has been loaned out on occasion.
- Standard practice for vehicles being replaced is to put them up for auction or they may become part of the new vehicle purchase deal.
- The replacement truck will be twice as fuel efficient as the unit being replaced and is part of the Fleet Management Program.

#### MUNICIPAL HALL INTERIOR - HERITAGE DESIGNATION

Recommendation from the November 27, 2014 Arts, Culture and Heritage Advisory Committee and report from Councillor Sanders dated November 27, 2014 recommending Council endorse the designation of the interior of the Saanich Municipal Hall as heritage, and direct staff to prepare the heritage designation.

MOVED by Councillor Sanders and Seconded by Councillor Derman: "That Council endorse the recommendation from the Arts, Culture and Heritage Advisory Committee and direct staff to prepare a report which identifies the significant interior heritage elements of the Saanich Municipal Hall, with the goal to prepare the Heritage Designation of the Hall."

Councillor Sanders stated:

- Staff are requested to prepare a report that identifies the heritage elements within the interior of the hall with the goal to achieve heritage designation.
- In 1991, the Municipal Hall was designated as a heritage structure based on its architectural structure; the interior design is of equal importance to heritage.
- The JC Scott report recognized the importance of the concrete interior walls, murals, terrazzo floors, fluted columns, teak features and art pieces; with heritage designation, the interior of the Hall will be recognized and protected.
- After heritage designation, sensitive changes can still be made to the interior.

#### Councillor Derman stated:

- He supports the motion; the JC Scott report showed that heritage elements were impinged upon over time.
- This is an important step; heritage designation does not deter from sympathetic changes to the interior.

#### Councillor Haynes stated:

- He agrees with the sentiment behind the preservation of heritage across Saanich and the Hall.
- Through the consultation process of the governance review, residents may recommend the reformat or redesign of the Council Chambers and it may be the dais is not desired.

#### Councillor Sanders stated:

 Staff will come back with a report identifying heritage elements; that may or may not include the dais.

#### Councillor Brownoff stated:

 The motion refers to identifying the heritage elements; it does not specifically refer to items pulled from the report.

## SAANICH NEIGHBOURHOOD PLACE CHILDCARE CONCEPT AT PEARKES RECREATION CENTRE

Report of the Director of Parks and Recreation dated December 11, 2014 recommending Council support the Saanich Neighbourhood Place childcare proposal in principle subject to the outcome of a public participation process and a formal development permit application review.

The applicant, C. Hobson, Executive Director of Saanich Neighbourhood Place, stated:

- Saanich Neighbourhood Place (SNP) is the only non-profit society serving all families in Saanich; SNP offers services and programs including family support, parent education, youth support, one-on-one and group programs, food security, emergency food cupboards and a weekly family dinner.
- There is a desperate need for childcare in our region; the proposed childcare centre will provide 24 infant/toddler spaces and 25 full time pre-school spaces.
- SNP will be applying to the Province of British Columbia for up to \$500,000 for a childcare capital grant.
- As part of the application for the grant, SNP is asking Saanich Council to agree, in principle, to providing up to \$200,000, which was secured as part of the RioCan development application.

#### **PUBLIC INPUT:**

R. Wickson, President, Gorge Tillicum Community Association, stated:

- The Community Association supports this application; the proposed development brings value to the community.
- Children will benefit from being close to the natural landscape; he looks forward to being part of the public participation process.
- M. Beauchamps, Director, Saanich Families in Action, stated:
- Saanich Families in Action are supportive of this initiative; there is a need for more services in the community that are family-oriented.

In response to questions from Council, the applicant stated:

- The proposed location for the proposed development is on the west side of Pearkes Recreation Centre at the rear of the building.
- If SNP is unsuccessful in getting funding from the Province, further fundraising will take place and there may be a need to apply for loans and grants.

In response to a question from Council, the Director of Planning stated:

- RioCan does not provide the \$200,000 until prior to issuance of a Building

Permit for the mixed use residential/commercial development; there is no projected timeline for this development.

In response to questions from Council, the applicant stated:

- In discussion with RioCan, it is hoped that development of the mixed use residential/commercial project would start in 2015 which would mean the funds would be available for SNP.
- If not, there may be a need for SNP to apply for a loan from the municipality which would be paid back if the funds were not received from RioCan.
- SNP cannot apply to the Province for funding without endorsement from Saanich; it is too early in the process to have a committed financial plan.
- The revenue base, when the program is full, is approximately \$150,000 to \$200,000 per year.
- The business plan can be forwarded to Council for review.

#### Motion:

MOVED by Councillor Derman and Seconded by Councillor Wergeland: "That it be recommended that Council support the Saanich Neighbourhood Place childcare proposal, in principle, subject to the outcome of a public participation process and a formal development permit application review."

Councillor Derman stated:

- SNP is to be congratulated for the programs they provide to the community; there is a reminder in the motion for the need for a public participation process and to look at the impact on environmentally sensitive areas.
- This recommendation does not commit Council to any financial obligation; it is solely an indication to the Province that Saanich endorses the project.
