THE CORPORATION OF THE DISTRICT OF SAANICH

BYLAW NO. 9722

TO AMEND BYLAW NO. 8940, BEING THE "OFFICIAL COMMUNITY PLAN BYLAW, 2008"

The Municipal Council of The Corporation of the District of Saanich enacts as follows:

- 1) Bylaw No. 8940, being the "Official Community Plan Bylaw, 2008" (the "**OCP Bylaw**") is hereby amended as follows:
 - (a) By deleting the fourth recital clause and replacing it with the following:

"AND WHEREAS an official community plan has been prepared for all areas of the District of Saanich, attached to this bylaw as Schedule "A" and comprising the following appendices:

Appendix "A" - General Plan

Appendix "B" - Blenkinsop Local Area Plan Appendix "C" - Cadboro Bay Local Area Plan

Appendix "D" - Carey Local Area Plan

(b) By deleting section 1 and replacing it with the following:

"The official community plan attached to this bylaw as Schedule "A" comprising appendices "A" to "P" inclusive and made a part of this Bylaw is hereby designated as the Official Community Plan for the District of Saanich.";

- (c) In section 8 of the Policies, Appendix "A" (General Plan), section 4.2.3 (Centres & Villages), by deleting the words "18 storeys" and replacing them with the words "24 storeys";
- (d) By adding the following text and map to section 1.0 "Introduction, Background" in each of Appendix "D" Carey Local Area Plan, Appendix "K" Saanich Core Local Area Plan, and Appendix "M" Tillicum Local Area Plan:

"Companion Plans

Local Area Plans work in concert with a number of other policy documents to provide quidance at the local level. Companion Documents often overlap local area

boundaries and, in some instances, can provide more current policy direction than what is included in the Local Area Plan.

The **Uptown-Douglas Plan**, adopted in 2021, is a comprehensive Plan that incorporates portions of four local areas: Saanich Core, Carey, Quadra, and Tillicum (see Map: Local Areas).

The Uptown-Douglas (UD) Plan area is a critical regional hub with an unprecedented opportunity to implement innovative approaches that further advance the vision and goals of the Official Community Plan. The UD Plan is unique in that its land use objectives encourage larger-scale developments and greater density than in other local areas of Saanich.

In situations where policy direction overlap or where there is direct conflict between the UD Plan and the existing Local Area Plans, the more recent Plan will take precedence.";

(e) By adding the following text to section 1.0 "Introduction, Companion Document" of Appendix "H" - Quadra Local Area Plan:

"The **Uptown-Douglas Plan**, adopted in 2021, is a comprehensive Plan that incorporates portions of four local areas: Saanich Core, Carey, Quadra, and Tillicum (see Map: Local Areas).

The Uptown-Douglas (UD) Plan area is a critical regional hub with an unprecedented opportunity to implement innovative approaches that further advance the vision and goals of the Official Community Plan. The UD Plan is unique in that its land use objectives encourage larger-scale developments and greater density than in other local areas of Saanich.

In situations where policy direction overlap or where there is direct conflict between the UD Plan and the existing Local Area Plans, the more recent Plan will take precedence.";

- (f) By adding the following text to each of section 9.0 "Housing" of Appendix "D" Carey Local Area Plan, section 4.0 "Residential" of Appendix "H" Quadra Local Area Plan, section 4.0 "Residential" of Appendix "K" Saanich Core Local Area Plan, and section 7.0 "Housing" of Appendix "M" Tillicum Local Area Plan:
 - "The Uptown-Douglas (UD) Plan, adopted in 2021, supplements the direction in the Local Area Plan. The UD area is expected to grow into a dense urban centre that leads growth with residential and provides a diversity of multi-unit residential housing choices, including affordable options and a variety of building typologies. When evaluating land use proposals, the UD Plan should be consulted for current policy guidance.";
- (g) By adding the following text to each of section 12.0 "Commercial" of Appendix "D" Carey Local Area Plan, section 5.0 "Commercial Industrial" of Appendix "H" Quadra Local Area Plan, section 3.0 "Commercial-Industrial" of Appendix "K" Saanich Core Local Area Plan, and section 10.0 "Commercial" of "Appendix "M" Tillicum Local Area Plan:

"The Uptown-Douglas (UD) Plan, adopted in 2021, supplements the direction in the Local Area Plan. A key objective of the UD Plan is to retain and increase


- employment in the area. The UD Plan should be referred to when assessing potential commercial, industrial and mixed-use land use development proposals.";
- (h) By amending Appendix "D" Carey Local Area Plan as follows:




Map 3.6 SHORT STREET


MAP 11.1 SAANICH CORE STRUCTURE MAP




Map 1.2 GENERAL LAND USE


