- 1. What type of housing is most needed in Cordova Bay and why?
 - No Garden suites
 - Multi-family condos, rentals for empty nesters and young professionals
 - Co-op housing
 - Condos including some larger sized (1000 square feet +)
 - 2 story townhouses. Might be more affordable for families
 - Lane way housing
 - Low income housing, especially for families with young children
 - Affordable housing for seniors and young families
 - Buildings to be no more than 3 stories in the village
 - Mixed housing types within new developments to encourage diversity
 - More density through low rise buildings. Preferably town houses of varying sizes
 - Garden suites on large properties only
 - Higher density housing on the west ridge
 - Mandatory green space and playground areas for all new apartment buildings. Exception for 55+ buildings
 - Housing that fits into neighbourhood LAP (as per guidelines)

 - Developers showing neighbours their plans
 - Bus service integrated with Royal Oak terminal (better link up available until 9pm?)
 - Better bus service
 - Coffee shop/bakery, library, better transit. Bring our independent dollar store back
 - Medical centre and dentist office
 - Neighbourhood pub
 - A pub would be wonderful! Yes to a fish store. An evening gathering place
 - Embracing youth
 - Coffee shop
 - Overnight commercial truck parking
 - Coffee shop, pub, grocery store
 - Safer biking path along Cordova Bay road so you can get to/from the village and beaches with children
 - Park/places for families and children. Library
 - Improved public transit into Victoria with more frequent and direct buses
 - Pub, Café, Paddle board rentals, ice cream shop open later than 6pm, community centre
 - Consider putting a radius around a specific type of business i.e. a pharmacy, such that another pharmacy cannot open within said radius
 - More amenities. Shops, pub/restaurant, grocery stores
 - What is meant by village? What area is considered the village?

- Paddle and boat (canoe/kayak) rental shop
- Local-use amenities that enhance the community and encourage walking, not large scale commercial that encourages out of area traffic
- Would be great for reasonable office space
- Medical clinic, café/library combo, hardware store
- LAP guidelines for village area ignored by Saanich in recent plaza permit decision
- Stay within the Lap for the village. We don't need Tuscany Village. Less imposing from the street level
- 30km/hr. zone for the village zone
- "Hangout" place for youth including yoga and wellness
- A traffic light at Doumac and Cordova Bay Rd
- I look forward to the new retail space at the plaza. Bookstore, Bank, grocery store, pharmacy, coffee shop, medical clinic
- No more 4 stories. Walkway between beach and Lochside. Coffee shops, medical clinic, deli shop, butcher/fish shop
- Community run fitness classes for all ages. Commonwealth Place is too far
- We should look to have an Island Savings Credit Union in our community
- Densifying the village with more housing/commercial and other uses will be great service to the neighbourhood
- Small theatre for art displays, concerts, community meet ups. A gathering place for the community
- We need doctor offices in the village
- Traffic calming on Cordova Bay rd. 5 or 6 lighted crosswalks
- Saanich council could begin by actually following VDG's and LAP's when issuing permits
- Grocery store and "mom and pop shops" rather than large commercial retailers
- Pub, fishmonger, ice cream and coffee shops all open in the evenings
- Like to see Scotiabank back in plaza
- Community facilities
- The plaza as approved is too big. Once complete we will not need more retail. Need to maintain smaller scale and semi-rural feel
- A pub would be a good compliment to the area
- Define village more carefully. Not all commercial and multi-residential
- On new subdivision create more walkthrough paths
- Low density multi-family and commercial with adequate parking
- Incorporate natural elements into new construction
- Doctor's office, dentist, grocery store, bank, library
- Retirement homes and better public transit
- Coffee shop, grocery store, restaurant, medical clinic, café
- Slower speeds on Cordova Bay Rd. Access from driveway on Cordova Bay rd. is challenging
- Better food at Beach house restaurant

- Please honour the green and informal landscape of Cordova Bay when planning improvements
- More amenities(restaurants, shops, pub, library)
- Keep developments low to up rural feel (not high rise)
- Boardwalk on the beach
- Green sustainable buildings
- New (bigger) facility for Cordova Bay 55+
- Slow the traffic down
- Sidewalks and curbs
- Limit height of new Village development below 4 storeys. Green building
- D.P. Guidelines that will outline/dictate "beach feel" architecture
- Retain or increase green space
- Add roundabouts and traffic lights at Doumac and Claremont
- Gathering area
- Walk-in medical clinic
- A pub
- Limit building height to 3 storeys for commercial developments
- Better transit schedules
- Mixed use development
- Limit size of developments to keep and protect our Village feel
- More accessible for families to bike to community garden/farm and other communal outdoor space
- To design Cordova Bay as a whole. Connective and cohesive with emphasis on people and livability

- Expand containment boundary to Sayward

- Please take in Trio land development that will happen in the next few years into your management of traffic for this Cordova Bay area
- 3. WHAT IDEAS DO YOU HAVE TO IMPROVE TRANSPORTATION AND MOBILITY IN CORDOVA BAY?
 - Overpass/Interchange at Pat Bay HWY and Haliburton
 - Sidewalk on Del Monte between Claremont and Haliburton. Lots of students walking on Del Monte
 - High profile notice or crosswalk for path from Claremont field to Del Monte. The view currently obstructs pedestrians to traffic on Del Monte
 - Add crosswalk on Cordova Bay Rd by Doris Page Park (access to playground)
 - Lochside Dr. between Claremont and Walema is so busy with bikes, car parking on the road, two lane traffic and pedestrians!!
 - Cordova Bay Rd. is unique in that there are no 4 corner intersections. Traffic calming is very important. Ensure safe pedestrian crossing, especially once the plaza is complete
 - More frequent bus services to downtown, Oak Bay and other areas
 - Make Sayward/Fowler/Cordova Bay roads open to "local traffic" only!
 - Presumably the frequency of transit in Cordova Bay will improve with more density. Safe crossing for pedestrians is critical (given the popularity of the beach) between Doris Page Park and Fenn
 - "No parking" on Boulevards? Be consistent throughout Saanich
 - No street parking on Lochside. It's so heavily used by cyclists and walkers (a good thing!)
 - Proper shoulders on both sides of Lochside Drive
 - If you want to reduce vehicle traffic, improve frequency of direct buses to and from Victoria. Otherwise buses are inconvenient and expensive
 - No parking on Lochside Drive
 - Sayward and Pat Bay HWY interchange/Overpass. Finish bike path on Fowler Rd
 - Stop commuter traffic from Central and North Saanich from cutting through Cordova Bay to Uvic and Shelbourne
 - Plan calls for expanded bike lanes on Cordova Bay Rd
 - Bike lanes on both sides of the road on Cordova Bay Rd. and Fowler Rd. Lochside Trail not appropriate for many types of bikes
 - More direct bus routes to downtown
 - Make it safer for kids and families to walk to and from the elementary schools People park all over Rambler Rd at school pick up time, including people's yards and driveways. It's dangerous!
 - Walking/bike trail connecting Rambler or Walema to the new plaza on the south side
 - Crosswalk with a push button light at Lochside Dr to Mattics (where trail ends)
 - Cordova Bay Rd traffic calming. Particularly form Haliburton to Treetop. People far exceed 40km/hr

- Safe crossings (flashing pedestrian lights) on all crosswalks along Cordova Bay Rd
- Better Bus service
- More people living in Cordova Bay just adds to traffic in neighbouring areas, e.g. Broadmead, Royal Oak. Need to plan for all considerations. Ensure local, walkable amenities (no cars needed)
- Better options for turning left out of Parker Ave. Cordova Bay Rd is very busy
- Bike activated road markings Lochside and Royal Oak travelling north
- Flashing lights on crosswalks!
- There needs to be traffic control at Claremont and Cordova Bay Rd. The hill on the left makes it difficult to see traffic coming on left while trying to pull on road with traffic coming on the right. Almost impossible at certain times of the day.
- Work with BC Transit to assess the need to improve direct Cordova Bay to downtown and Cordova Bay to Uvic bus connections. (No transfers)
- Very difficult to exit from Fable Beach (either right or left) for both pedestrians (no sidewalk), cyclists and cars. Slow traffic down through portable speed recording devices (signs), traffic circles? Police enforcement?
- Possible roundabouts as on Vancouver streets?
- I agree with and appreciate the work of the CBA Transportation Committee. Please work closely with them. They reflect all of our issues
- Widen Doumac and sidewalks on each side, due to increased traffic. Add parking to access Plaza merchants and restaurant
- Consistent bike lanes along Cordova Bay Rd
- Widen one side of Lochside Dr. Very congested with bikes
- Traffic circle at Doumac and Cordova Bay Rd
- The bus lane lights arrangement where Sayward Rd meets the Pat Bay HWY is dangerous
- Parker/Fenn corner is dangerous for pedestrians
- Widen one side of Cordova Bay Rd. Bike lanes in Mt. Doug Park
- Better traffic management is needed at Galey Way, especially as volumes increase due to new developments
- Continuous bike lanes the entire length of Cordova Bay Rd (especially with the increased traffic coming)
- Bike lanes and sidewalks before 2036
- Lochside Dr between Claremont and Cordova Bay Rd is so busy with bikers, pedestrians, 2 lane car traffic and parked cars! Need dedicated pedestrian sidewalk! Please!
- It's dangerous due to visibility to turn onto Cordova Bay Rd (both ways) from Galey Way. Increased traffic will make it worse
- Saanich to do research on Cordova Bay Rd. Major route of special design
- Safe way to access the beaches from Cordova Bay Rd if you walk/bike
- Crosswalk at Rambler and Cordova Bay Rd
- Better direct transit service to downtown
- Reduce speeding and traffic volume on Cordova Bay Rd. People pass me regularly as I observe the speed limit. They endanger everyone

- Consistent bike lanes the whole length of Cordova Bay Rd
- Advanced green light required for traffic turning left and heading south on HWY from Sayward
- Turning right onto Keating X Rd. from Pat Bay HWY is a death trap. Must change
- Overhead pedestrian walkway to Elk Lake
- As a young adult with a disability, my current option for transportation is Handy Dart. If we had better bus service this would increase my access to my community
- Please avoid access across Cordova Bay Rd from new Aragon development to Sayward Hill Cr. Median?
- Reduce speed limit on Cordova Bay Rd to 30km/hr, with enforcement
- Connect community assets (Lochside Park, Doris Page Park and Cordova Bay Park) with safe crossings
- Traffic calming measures along Cordova Bay Rd
- Widen road. Need more options to slow down or re-route traffic on Cordova Bay Rd through Mt. Doug
- Safe route to school along Lochside does exist but has become a parking area for cars and is no longer a safe route for school children as they have to go around the cars
- More frequent and direct busses to downtown or at least parking near bus loop
- How will people get from their cross streets (Fenn, for example) on to Cordova Bay Rd when it gets even busier? Sometimes it's near impossible at times when school starts and finishes when people are picking up their kids
- Need traffic lights at GaleyRd, Claremont Rd and Doumac Rd
- Cut down traffic on Lochside Rd to yielding street
- Lochside, from McMinn Park to Cordova Bay Rd is a "road". To call it part of Lochside "Trail" is an insult to our intelligence
- Need a traffic light with on demand crosswalk at Doumac and Cordova Bay Rd
- Glad to see "to be constructed" bike lanes signs on Cordova Bay Rd
- Put in roundabout at Doumac and Cordova Bay Rd
- When building bike lanes, shift the bus stop in front of the church, not in front of the house two doors down from the church where it is now. That way the house can have parking in front of it and the church can provide seating
- Because of the topography of Cordova Bay, pedestrian trails to access from ridge to beach are vital (not many cycle up Claremont)
- Like to see sidewalk on both sides close to Royal Oak on Cordova Bay Rd at entry to Mt.Doug Parkway. Hard to cross over
- Sidewalk on Lochside (for safety, walking with small children)
- Lochside Dr. between Claremont and Cordova Bay Rd needs a dedicated pedestrian only sidewalk. My kids cannot safely walk to school at Cordova Bay and we only live 500m away on Lochside!
- Sidewalks from Claremont to the north end of Del Monte
- Major road of special design! This designation allows for 2 lanes only traffic and calming
- Traffic flow extends from Royal Oak Dr to Sayward. Fowler=Cordova Bay Rd. Fowler is also a "major" road

- Cycle lanes on both sides of Cordova Bay Rd
- Slow traffic on Lochside and Cordova Bay Rd to 40km/hr
- Define boundaries of pedestrians, cyclists and cars on Lochside
- No street parking on Lochside
- Speeding is too common. More signs needed. Traffic calming devices on Cordova bay Rd similar to those on Lochside. I've been pass to many times while observing the posted speed limit
- Mirror opposite 5187 (Fable Beach) to see oncoming traffic from the south
- Slow down traffic on Cordova Bay Rd. Do not widen as this would have a dangerous impact on properties situated along this busy road. It would amplify existing safety issues and would not address speeding. Suggestion for speed enforcement and better management of intrusive foliage
- Concern at intersection of Sayward, Hill Cres and Cordova Bay Rd regarding entrance to the Aragon property and traffic using Sayward and Hill Cres as route through
- Cordova Bay Rd hill from the bottom of Aragon property to the top of the hill, speed is excessive in both directions. How to slow traffic?
- Dead end Lochside Rd at the south side of the Maxine Lane to reduce traffic at McMinn Park and on Lochside trail
- Widen Lochside, from McMinn Park all the way to Matticks Farm. Currently unsafe for walking or cycling
- As per existing LAP, re-evaluate putting Lochside through to Royal Oak
- Traffic calming is imperative for the Cordova Bay-Fowler corridor. Make it 40km/hr consistent over the full length. With 30km/hr exceptions
- Safer pedestrian access across Cordova Bay Rd
- Frontage road along Pat Bay Hwy between Claremont and Sayward
- Left turn improvements to sight lines at Claremont and Cordova Bay Rd
- More calming and safety for all road users. Flashing speed alert signs
- Safety at Cordova Bay Rd. and Gloria Place. Flashing light at crosswalk
- Turning lane advance phase out pod Sayward Rd
- We live on Cordova Bay Rd. Agreed that the volume is high, but it's the speed of vehicles. Not stopping at crosswalks. Treating the playground zone like it's optional. Worry about additional volume with gravel pit development
- Install a crosswalk at Lochside and Mattick's farm. Everyone crosses there!
- Traffic and speed on Cordova Bay Rd with additional development and density increase. Improved access to south bound Pat Bay?
- Zebra crosswalk at Westley and Haliburton
- Encourage more walking with safe sidewalks to all amenities including beaches
- Work closely with the CBA Transportation Committee in regards to transportation issues in Cordova Bay
- Slow traffic on Haliburton, Wesley and Sea Ridge Drive
- Install traffic calming measures along Santa Clara
- One way traffic on Lochside to allow room for bikes/pedestrians between Claremont and Walema
- More frequent buses

- Improve ability to walk and bike. People need to feel safe when riding their bike
- 2 lane access from Sayward to downtown Victoria. Left turn light
- Pedestrian walkways across Pat Bay HWY
- Cordova Bay Rd is too narrow for bikers to feel safe
- Increase the green!
- It will create a lot more traffic once new plaza and Trio developments are completed
- More roadside green paths
- Speed signs on Cordova Bay Rd
- Need to slow down cars
- Cordova Bay Ridge is not serviced adequately by public transit. A few extra buses at Claremont start/end of the day does not get us adults out of our cars for work/shop/play
- More roadside walking paths, like 5000 block of Lochside
- More electric car charging stations
- Re-open Cordova Bay Rd south bound access to Hwy 17
- Buses on time!
- More sidewalks
- Direct transit to Cook street and downtown improved
- Very concerned about additional traffic
- Traffic calming to reduce car speed where walkers and traffic mix. Stop signs are not enforced, so they are not the answer
- Crosswalk at Agate and Cordova Bay Rd
- If bike lanes are to be built, they must be maintained
- Trio development will hugely impact the Village and add a lot more traffic which means changes to Cordova Bay Rd and Lochside Trail
- Cordova Bay Rd needs stop signs/roundabouts, boulevards, better bike lanesways to slow traffic and discourage this route as a "short cut" to the University, hospital etc..
- No traffic light at Doumac and Cordova Bay Rd. A roundabout makes more sense
- Lochside should be expanded for cars and bikes
- Put in a light at Doumac sooner rather than later
- 3way stop at Claremont/Cordova Bay Rd
- Make the parking bay at Cordova Bay Rd and Claremont smaller to increase visibility turning left from Claremont towards the Beach House
- Traffic light at Cordova Bay Park
- Proper sidewalks and concrete barriers on Claremont Hill to Cordova Bay Rd
- We need traffic lights at Doumac and Cordova Bay Rd
- Segregated Bike lanes (no one wants to share the road with vehicles)
- We need a dedicated traffic study including: Peak traffic per hour at selected locations along Cordova Bay Rd and estimated future daily and peak traffic flow along Cordova Bay Rd, including Through flow
- Crosswalks (lit)/roundabouts
- Better bus service

- Turn Cordova Bay Rd into a scenic drive- slow traffic down
- Discourage speed and cut through traffic Mt. Doug to Sayward
- Drive "40" on Cordova Bay Rd. Encourage your neighbours' to slow down too!
- Should Lochside Dr. be one-way so that cyclists and pedestrians have more space
- More bike lanes
- Stricter control of speeds and better signage of speed limits/park and school
- Flashing speed alert boards (permanent installs)
- Design the traffic from Aragon in such a way that it favours going via Sayward 9discourages going to Cordova Bay Rd)
- More electric car charging stations
- Electric cabs instead of hybrid
- Cars should not be allowed to park along Lochside as it reduces space for cars/cyclists to share the road
- Lochside Rd needs a designated walking area to separate cyclists/cars/walkers. Could easily be simply edged and gravel like the old trail
- More electric cars. Less gas stations
- Slow down the traffic to the actual speed limit. Not the 60-80km/hr it is now
- Parking only on one side of Lochside
- Require properties to have enough parking. Two parking spots are not enough
- Reduce transient traffic
- Transit sucks in Cordova Bay
- Sidewalks and curbs
- Sidewalks and bike lanes on Lochside. Currently unsafe
- No parking signs on Del Monte
- We need a plan in anticipation of self-driving vehicles. (it's coming)
- Better lit crosswalks (LED tech)
- Buses on time and not so close one to one
- Lochside should not be a through street. Currently- narrow road, parked cars, bikes, cars and pedestrians- no sidewalks
- It's essential to consider the impact of the upcoming developments (Aragon etc..) on Cordova Bay Rd traffic flows
- Need traffic calming features on Del Monte
- Sidewalks both sides
- More regular bus
- Actually a 3 way stop at Claremont and Cordova Bay Rd. It is difficult to make a left from Claremont onto Cordova Bay Rd
- Traffic light at Doumac once new development goes up
- Put a cable-car service parallel to Pat Bay Hwy
- Stop sign at Claremont and Cordova Bay Rd. Limited visibility now
- 4. WHAT IDEAS DO YOU HAVE TO IMPROVE PARKS, TRAILS, AND COMMUNITY FACILITIES IN CORDOVA BAY?
 - Concerned about the washroom and that it might attract unwanted element to the park and neighbourhood

- Better supervision of off leash dogs on Parker Park beach
- Safe bike lanes for families and small children before 2038
- Provide some public use/access at the unconstructed beach row of the Totem Lane
- Removal of invasive plants and estuary rehabilitation at Galey Brook
- More parks and safe places for families and children
- Love the new McMinn Park. More parks like McMinn
- 2nd turf field at Lochside Park
- Work towards meeting OCP goal of 5%. Focused properties that can celebrate the waterfront orientation by giving more public access and facilities
- Add to Doumac trail network from base of steps to Delmonte
- Off-leash dog park at McMinn Park
- The forested trails are a real asset for the community. Keep them and add to them where possible
- Put an "outdoor work-out" set of equipment at Agate Park
- Stop Mountain biking in Doumac Park
- Fix the drainage issue at McMinn Park so people can play in the field. It's still not draining
- Play structures at Agate Park. Off leash park area for dogs
- Lochside rd./trail should be majority one way traffic to make it safer for pedestrians, cyclists and drivers
- Agate Park is so nice with parking and beach access but needs a playground
- Need East/West pedestrian connection less steep. Lower grade
- Saanich is not maintaining the forested ravines in Cordova Bay. Trees are dying and are left to rot, providing dry combustible wood which could catch on fire in dry summers. Saanich does not replace dying trees. Rejuvenate forested ravines like Doumac and Beckton Parks
- Washrooms and change rooms at Agate Park
- To improve Doumac and Beckton parks, a tree renewal/planting project should be undertaken as older trees die off, or else we will have less and less tree canopy left. Something many of us value
- Relocate Cordova Bay Park away from major traffic artery. 30km/hr. is ignored by 95% of drivers. Park is seldom used
- Given that Cordova Bay is below the park standard and growth is predicted, the options should be increasing the number of parks or decreasing the residential population and developments
- Unlock the washrooms at Lochside Park!
- Please develop beach access at the current unconstructed right of way at Totem and Major
- Install a pedestrian crosswalk with lights in 30km/hr. zone across the little playground on Cordova Bay Rd past the beach house. Few people slow down or see the need to
- Washrooms at McMinn and unlock the washrooms at Lochside Park
- Work to improve access and facilities for the humble but well located Cordova Bay Park. This should be a personal water craft focused area (kaya, paddleboard etc...) Community use of the beach and bay

- The Coast Salish village "Tseleethch" is located in Cordova Bay (near Agate Lane) and had been occupied for centuries. Fragile archaeological remains from this village and related sites continue in our community. 1892 the South Saanich

Treaty is signed between Douglas and the ancestors of Wsanec Lekwungen communities. Our treaty relationship continues from this and should be recognized and implemented
