## Introduction



### Purpose of the Plan:

The purpose of the Agriculture and Food Security Plan (AFSP) is to provide the District with a coordinated approach for supporting agricultural activity and improving food security in Saanich. The Plan is being developed to provide clear direction for decisions and action over the next 10-15 years.




# Planning Process

The project began in February 2016 and is expected to be completed in early 2018. A Task Force of community experts is serving as a touchstone throughout the project. Key points of community engagement include:

- Five task force meetings
- Community survey on issues and opportunities completed by 289 community members and farmers
- Open House on issues and opportunities attended by 40 people
- Over 20 meetings with local community food stakeholders and organizations
- Pop-up displays at Saanich festivals and food-related businesses
- A community workshop to review potential actions attended by 70 people.
- Presentations and feedback sessions with Saanich Advisory Committees
- Promotion through social media, including Facebook and Twitter.




# Saanich Context

Saanich is the largest municipality in the Capital Regional District and has the unique characteristic of being roughly half rural and half urban.


**Two key tools have helped preserve farmland and protect rural lands from development pressure:**

- The **Urban Containment Boundary**, introduced in 1964, restricts development densities outside urban areas and also limits the provision of sewer and water service.
- The **Agricultural Land Reserve**, introduced in 1974, is a Provincial land designation that restricts any non-farm use on properties with a high agricultural value.

## Vision Statement

**In Saanich, food security starts in our backyard.**

By 2030, Saanich is home to a thriving, accessible, and environmentally responsible food system, which is renowned for its vibrancy and resiliency. Our food is celebrated and recognized for its role in nourishing people, livelihoods, and relationships. Saanich is seen as a leader in advancing food security, including initiatives toward greater food self-sufficiency on the South Island, as well as dignified access to affordable, healthy food for all people. Ecosystems flourish as a result of responsible land and water stewardship on both urban and rural agricultural lands, which form the centre of our community. We protect and support our farmland and are proud to provide a vibrant agricultural legacy to future generations.






# Plan Implementation

## Implementation Strategy

The implementation strategy complements the broader Agriculture and Food Security Plan by helping provide clarity around how the Plan will be implemented. It sets priorities for action and helps to differentiate between priority actions that can be undertaken as specific projects and ongoing actions that will provide continual guidance for decision making. All actions in the Plan were developed in consultation with the Task Force and input from the public.

The Implementation of the Plan is organized through three phases of work with approximately 13 Priority Actions per phase. The Priority Actions are specific activities that can be undertaken over the next 10 –15 years to advance the vision and objectives of the Plan. The three phases of work would be undertaken sequentially, with some flexibility to adjust priorities according to funding available, partnerships or other opportunities that may arise.



## Monitoring and Evaluation Strategy

A Monitoring and Evaluation Strategy has been developed to assess the effectiveness of the Plan in enhancing agriculture and food security in the community. Twenty two indicators have been identified and will be reviewed regularly.
