Saanich Energy Evaluation Grant (Limited Offer)

Terms and Conditions

Offer

- 1. The Saanich Energy Evaluation Grant (*"the Grant"*) offers a pre-retrofit EnerGuide Home Evaluation at a reduced price to eligible participants.
- 2. Participants that qualify for this offer will receive:
 - a. A grant that reduces the cost of an Energy Evaluation by the following amount:
 - i. A \$350 grant for standard-stream participants;
 - ii. A \$550 grant for *income-qualified stream participants;* and
 - iii. An additional \$75 grant for the "inaccessible suite fee" where applicable; and
 - b. A one-hour consultation with the program-partnered Energy Advisor on the results of the pre-retrofit EnerGuide Home Evaluation, free of charge.

Eligibility

- 3. To qualify for the Grant, participants must:
 - a. be approved for participation in the Saanich Heat Pump Financing Program; and
 - b. have opted into the Grant, and have received confirmation that they have secured the Grant.
- 4. The Grant is only available for EnerGuide Home Evaluations that are:
 - a. booked with a program-partnered Energy Advisor; and
 - b. completed within three (3) months of receiving confirmation of the Grant, as set out in section 3(b). A one-time written request for extension will be considered at the Program's discretion.



Process

- 5. Participants will be referred to a program-partnered Energy Advisor who will contact the participant directly to set up the appointment and provide the participant, in writing, the total estimated cost for the EnerGuide Home Evaluation, including any additional fees and accounting for the eligible Grant amount(s).
- 6. After completion of the Energuide Home Evaluation, the grant amount as outlined in Section 2(a) above will be paid directly to the Energy Advisor by the program administrator.
- 7. The participant will be invoiced by the Energy Advisor for any outstanding amount, and will be responsible to pay the Energy Advisor directly for that outstanding amount, including, without limitation, any extra square footage fee that the Energy Advisor may charge.

Participant Consent

- 8. By registering for the Grant, participants consent to:
 - a. the collection of personal information which is authorized under the Local Government Act, Community Charter and section 26 (c) and (e) of the Freedom of Information and Protection of Privacy Act. The information will be used for administering and evaluating the Program.
 - b. the disclosure of the personal information collected during their energy evaluations by the partnered Energy Advisor to City Green Solutions for the purposes of program evaluation, including measuring energy and greenhouse gas savings;
 - c. the disclosure of their EnerGuide Home Evaluation file numbers by City Green to Natural Resources Canada (NRCan) for program evaluation purposes;
 - d. the disclosure of their EnerGuide Home Evaluation data by Natural Resources Canada to City Green for the purposes of programpartnered evaluation; and
 - e. the disclosure of their EnerGuide Home Evaluation file numbers and evaluation data by City Green and/or the program-partnered Energy Advisor to the District of Saanich for program administration, evaluation, and reporting purposes.



No Liability

- 9. The District makes no representations or warranties whatsoever as to the fitness of, the necessity for, the quality of, or skill of any Energy Advisor, and for greater certainty, the program-partnered Energy Advisor is not a contractor of the District.
- 10. The participant hereby indemnifies and saves harmless the District, its elected and appointed officials, officers, agents, employees and contractors, from all liability, damages, claims, demands, expenses and costs for claims, costs for injury or death of any person, damage to or destruction of property, and all economic loss suffered by any person (collectively, the "Losses") arising from or occurring by reason of the Participant's participation in the Grant, including the use of a partnered Energy Advisor.
- 11. The participant irrevocably waives any and all claims against and irrevocably releases and agrees not to sue the District, its elected and appointed officials, officers, agents, employees, and contractors for and against all Losses arising out of the participant's participation in the Grant, including the use of the a program-partnered Energy Advisor.

General Terms

- 12. The Grant program is limited to a total of 40 participants, with 20 spots specifically reserved for income-qualified participants. The Grant is offered on a first-come, first-served basis, until all spots are filled.
- 13. The District of Saanich reserves the right to end this offer at any time without notice.
- 14. The Grant shall be eligible for EnerGuide Home Evaluations that are completed on or after May 12, 2025, and available while funds last.
- 15. The Grant is not retroactively available to those participants who have already completed their EnerGuide Home Evaluation in support of the Heat Pump Financing Program.
- 16. Participants who receive the Grant are not restricted or prohibited from accessing other grant streams, including but not limited to the CRD Neighbourhood Energy Navigator Offer.
