BYLAW NOTICE ENFORCEMENT BYLAW

The Municipal Council of The Corporation of the District of Saanich, in open meeting assembled, enacts as follows:

PART 1 – Definitions

1.1 In this Bylaw:

“**Act**” means the *Local Government Bylaw Notice Enforcement Act*;

“**District**” means the Corporation of the District of Saanich;

“**Registry**” means the District of Saanich Bylaw Notice Adjudication Registry established under Part 5 of this Bylaw;

1.2 Words and expressions not otherwise defined in this Bylaw have the meaning assigned in the Act.

PART 2 – Bylaw Contraventions

2.1 The bylaw contraventions designated in Schedule “A” may be dealt with by bylaw notice.

PART 3 – Penalties

3.1 The penalty for a contravention referred to in section 2.1 is as follows:

- a) subject to paragraphs b), c) and d), the penalty set out in Column 3 of Schedule “A”;
- b) if received by the District within 14 days of the person receiving or being presumed to have received the bylaw notice, the penalty set out in Column 3 of Schedule “A” reduced by the amount of the early payment discount set out in Column 4 of Schedule “A”;
- c) if received by the District more than 28 days after the person received or is presumed to have received the bylaw notice, the penalty set out in Column 3 of Schedule “A” increased by the amount of the late payment surcharge set out in Column 5 of Schedule “A”; or
- d) if paid under a compliance agreement, the penalty set out in Column 3 of Schedule “A” reduced by the compliance agreement discount as provided under Column 6 of Schedule “A”.

PART 4 – Period for Paying a Disputed Notice

4.1 A person who receives a bylaw notice must, within 14 days of the date on which the person received or is presumed to have received the bylaw notice:

- a) pay the penalty, or
- b) request dispute adjudication

by filling in the appropriate portion of the bylaw notice indicating either a payment or a dispute and delivering it, or causing it to be delivered or mailed, to the District's Municipal Hall at 770 Vernon Ave., Victoria, BC, V8X 2W7 or by leaving it in the District's after-hours mailbox outside the Municipal Hall at 770 Vernon Ave., Victoria, BC.

4.2 A person may pay the indicated penalty more than 14 days after receiving the bylaw notice, in accordance with section 4.1(a), but no person may dispute the bylaw notice more than 14 days after receiving the bylaw notice.

4.3 Pursuant to the requirements of section 25 of the Act, where a person was not served personally with a bylaw notice and advises the District that he or she did not receive a copy of the original bylaw notice, the time limit for responding to a bylaw notice under section 4.2 of this Bylaw does not begin to run until a copy of the bylaw notice is re-delivered to that person in accordance with the Act.

PART 5 – Bylaw Notice Dispute Adjudication Registry

5.1 The Registry is established as a bylaw notice dispute adjudication system in accordance with the Act to resolve disputes in relation to bylaw notices.

5.2 The civic address of the Registry is 770 Vernon Ave., Victoria, BC, V8X 2W7.

5.3 Every person who is unsuccessful in a dispute adjudication in relation to a bylaw notice or a compliance agreement under the dispute adjudication system established under this section must pay the District an additional fee of \$25 for the purpose of the District recovering the costs of the adjudication system.

PART 6 – Screening Officers

6.1 The position of screening officer is established.

6.2 Persons acting in or hired to the following positions or titles may act as screening officers:

- a) Director of Building, Bylaw, Licensing and Legal Services;
- b) Manager of Inspections; and

the Director of Building, Bylaw, Licensing and Legal Services is hereby delegated the authority to appoint or rescind the appointment of screening officers from these classes of persons by name, name of office or otherwise.

PART 7 – Powers and Duties of Screening Officer

- 7.1 The powers and duties of screening officers are as set out in the Act and include the following:
- a) the screening officer must, upon receipt of a request for dispute adjudication from a person against whom a contravention is alleged, advise the person of the bylaw notice adjudication system established by this Bylaw, including, without limitation, advise the person of the action which the screening officer may take pursuant to this section 7.1 with respect to the bylaw notice and of the opportunity to proceed to dispute adjudication of the bylaw notice;
 - b) where requested by the person against whom a contravention is alleged, communicate information respecting the nature of the contravention, the provision of the bylaw contravened, the facts on which the contravention allegation is based, the penalty for a contravention and the fee or fees payable in relation to the bylaw notice enforcement process;
 - c) communicate with any or all of the following for the purposes of performing their functions under this Bylaw or the Act:
 - i. the person against whom a contravention is alleged or his or her representative;
 - ii. the officer issuing the notice;
 - iii. the complainant or his or her representative;
 - iv. the District's staff regarding the disputant's history of bylaw compliance;
 - d) review the District's records regarding the disputant's history of bylaw compliance;
 - e) prepare and enter into compliance agreements under the Act with persons who dispute bylaw notices, including establishing terms and conditions for compliance that the screening officer considers necessary or advisable, including time periods for payment of penalties and compliance with the bylaw;
 - f) provide for payment of a reduced penalty if a compliance agreement is entered into, as provided in Column 6 of Schedule "A"; and
 - g) cancel bylaw notices in accordance with the Act and District policies and guidelines.
- 7.2 The bylaw contraventions in relation to which a screening officer may enter into compliance agreements are designated in Column 6 of Schedule "A".
- 7.3 The maximum term of a compliance agreement is one (1) year.
- 7.4 For purposes of Column 6 of Schedule "A", where the expression "n/a" is used, it means "not applicable", and indicates that with respect to the contravention listed in that row of Schedule "A":
- a) a compliance agreement may not be entered into; and

- b) there is no reduced penalty available under Column 6.

PART 8 – Bylaw Enforcement Officers

- 8.1 Persons acting as any of the following are designated as bylaw enforcement officers for the purposes of this Bylaw and the Act:
 - a) Municipal constables;
 - b) Bylaw Enforcement Officers appointed pursuant to the *Police Act* and the *Community Charter*;
 - c) Municipal fire officers;
 - c) Bylaw enforcement officers, building officials, pound inspectors, license inspectors or other persons acting in another capacity on behalf of the District for the purpose of enforcement of one or more of its bylaws.

PART 9 – Establishment of Forms

- 9.1 The Director of Building, Bylaw, Licensing and Legal Services may from time to time establish the form or forms of the bylaw notice, provided that the bylaw notice complies with Section 4 of the Act.
- 9.2 The Director of Building, Bylaw, Licensing and Legal Services may from time to time establish one (1) or more forms of compliance agreement for purposes of this Bylaw.

PART 10 – Schedules

- 10.1 The following schedule is attached to and forms part of this Bylaw:
 - a) Schedule “A” – Designated Bylaw Contraventions and Penalties.

PART 11 – Severability

- 11.1 If a portion of this Bylaw is held invalid by a Court of competent jurisdiction, then the invalid portion must be severed and the remainder of this bylaw is deemed to have been adopted without the severed section, subsection, paragraph, subparagraph, clause or phrase.

PART 12 – Citation

12.1 This Bylaw may be cited for all purposes as the “**BYLAW NOTICE ENFORCEMENT BYLAW, 2018, NO. 9525**”.
