BYLAW NO. 9688

TO IMPOSE FEES FOR SEWER, WATER AND STORM DRAIN CONNECTIONS

The Municipal Council of The Corporation of the District of Saanich in open meeting assembled enacts as follows:

Definitions/Interpretation

- 1. In this Bylaw:
 - a. **"At Cost"** means the actual cost of the work as determined by the Municipality, which includes the amount expended by the Municipality for gross wages and salaries, employee fringe benefits, materials, equipment rentals at rates paid by the Municipality or set by the Municipality for use of its own equipment, administration charges, applicable taxes, and any other expenditures incurred in doing the work.
 - b. **"Municipality**" means The Corporation of the District of Saanich.
 - c. **"Sanitary Sewer Bylaw"** means the Sanitary Sewer Bylaw, 2006, No. 8792, as amended and replaced from time to time.
 - d. **"Water Utility Bylaw"** means the Water Utility Bylaw, 2000, No. 8124, as amended and replaced from time to time.
 - e. **"Watercourse and Drainage Bylaw**" means the Watercourse and Drainage Regulation Bylaw, 1996, No. 7501, as amended and replaced from time to time.
- 2. There is hereby imposed upon every person obtaining a service or work listed under Column 2 of Schedule 'A' attached to this Bylaw the corresponding fee listed under Column 3 of Schedule 'A', to be paid to the Municipality.
- 3. This Bylaw may be cited for all purposes as the "SEWER, WATER AND STORM DRAINAGE CONNECTION FEE BYLAW, 2021, NO. 9688".
