## Natural Areas, Parks & Trails Advisory Committee Terms of Reference

#### Mandate

The mandate of the Natural Areas, Parks & Trails Advisory Committee is to provide recommendations, advice and information to Saanich Council and staff on matters that relate to the purpose of the committee and on any matters which are referred to the committee by Saanich Council or staff.

#### **Purpose**

The purpose of the Natural Areas, Parks & Trails Advisory Committee is to:

- Advise Saanich Council and staff on:
  - o urban forestry matters
  - policies on parks, trails and natural areas, including services, facilities and specific community interests.
- Provide a community perspective on services, programs, events and capital projects related to urban forestry, natural areas, parks, trails, facilities and related community programs.
- Foster public awareness, recognition and support for a healthy and sustainable natural environment and parks, trails and facilities.

#### Meetings

The Committee will meet a minimum of four times per year in accordance with its regular schedule of meetings established annually at the first meeting of the year. No meetings are held during the summer and winter breaks (July, August and December). Special meetings may be held at the call of the Chair. The meeting rules and procedures will be in accordance with the Council Procedure Bylaw. Quorum of the Committee is a majority of its appointed voting members, including the Chair.

#### Membership

To the extent possible, Advisory Committees will have a diverse membership with respect to gender, age, and cultural-ethnic background.

The Committee will consist of eleven (11) members qualified in the discipline relevant to the committee mandate or with a perspective necessary for fulsome consideration of the associated topic, including:

- A member of Council to serve as Chair, appointed by the Mayor;
- Ten (10) community representatives appointed by the Council including, where possible, one (1) youth voting member described as 16-24 years of age; and
- Where possible, at least one (1) member who is an Indigenous person.

Members may serve a maximum of seven years on an Advisory Committee, consisting of a one-year term followed by a potential for three, two-year terms. Members who wish to be re-appointed after the completion of a term must re-apply and provide the application and their resume for Council's consideration.

School District Nos. 61 and 63 may each assign a trustee to the Committee as a non-voting liaison.

#### **APPROVAL OF MINUTES**

MOVED by P. Carroll and Seconded by D. Wick: "That the Minutes of the Natural Areas Parks and Trails Advisory Committee meeting dated October 12, 2023 be adopted as circulated.

**CARRIED** 

#### **CHAIR'S REMARKS**

The Chair welcomed the committee, and the following was noted:

- The Capitol Regional District (CRD) has purchased the former Royal Oak Golf Course parcel of land. A park values inventory will be undertaken. Through ecological restoration, the landscape could support a large diversity of species.
- A motion was passed by the CRD that any maintenance or improvements required at Elk and Beaver Lake Parks will be handled through property taxation and grants. Free parking will remain.

#### PROSPECT LAKE HYDRO GROUP

The guest speaker made the following presentation, and the following was noted:

- All options have been exhausted through the Municipal and local Constituency Office. The co-operation and assistance from Saanich staff are appreciated.
- Ongoing communication and persuasion from Saanich citizens and staff have been unsuccessful.
- The planned tree loss has grown from 362 to 485 trees. An estimated 98% are believed to be native species and mature protected trees.
- A BC Hydro representative stated the project could proceed at any time within the next 3

years.

- This project is environmentally destructive and is designed to service only 100 properties along 4.8 km.
- A focus on replacement trees is unobtainable.
- This project may only be adjusted via a political solution. The ministers responsible for BC Hydro, resource management and climate mitigation actions demand to mediate a solution; to place this project on hold in order to allow for a thorough review of its planned route and its effects.
- A strategy has been sent to Lana Popham, Minister of Tourism, Arts, Culture and Sport; Josie Osborne, Minister of Energy, Mines and Low Carbon Innovation; and Nathan Cullen, Minister of Land, Water and Resource Stewardship. These Ministers may direct BC Hydro to investigate alternate routes and have transparency in communication.
- The recommendation contained in the report (on file) from Councillor Brownoff is supported by the Prospect Lake Road Trees Advocacy Group.
- A future initiative to work with Ministries and communities to curb BC Hydro's excessive power is key.
- The Hydro and Power Authority Act [RSBC 1996] Chapter 212 needs updating.

#### **ACCESSIBILITY AND UNIVERSAL DESIGN IN PARKS**

The Manager of Parks, Planning and Development gave the following presentation (PowerPoint on file), and the following was noted:

- Accessibility guidelines and strategies are used within parks.
- Universal design and signage that is easy to read is a general rule.
- 8 accessible washrooms have been upgraded.
- Useable and accessible trail systems have been enhanced on Mt. Tolmie.
- Playgrounds are replaced and repaired regularly. Equipment is constantly upgraded.
- Wood chips qualify as an accessible surface material.
- Playground equipment have transfer stations for physical or visually handicapped children.
- The beach mat at Gyro Park is the only one in Saanich. It is challenging to keep clear from debris but is well used.
- The benches at Lambrick Park are designed to be accessible. The tables have extended ends and concrete pads for wheelchairs.
- The Enabling Accessibility Fund has provided some funding for various projects in Saanich's parks.
- Topography is a challenge in many of the parks.
- The leash optional parks have wider trails and grades that will allow for all users.
- Enclosed leash optional areas could be developed with wider gates to enter, material to accommodate walking aids and wheelchairs, seating, and clear signage.
- The People, Pets, Parks strategy is not a design concept. The considerations are part of the design process. Saanich is currently in the strategy stage.
- PKOLS parking lot is having several upgrades done to the walkways and curb letdowns.
- A future presentation to the committee about Park design is welcome.
- Information gathered from the Pop-up Dog Parks pilot project has offered insight for future facilities and the amenities they could provide. The learning outcomes included the durability of the fencing and the maintenance requirements for the turf. This program was

in place for 5 months. A phased approach is expected, and new locations could be explored.

The committee made the following comments:

- Francis King Park's boardwalk is accessible and could be a design for future projects.
- Saratoga Beach has a mat strategically placed to allow access for all abilities while protecting the entry area from varying weather conditions.
- Saanich does not offer advice to other accessibility plans or reviews.

#### **BC HYDRO PROJECT - REPORT**

The Chair introduced the report, and the following was noted:

- In early 2023, BC Hydro approached the District of Saanich with a proposed project to upgrade high voltage power lines along Prospect Lake Road from Meadowbrook to Munn Road.
- The community has indicated to Saanich that residents have not seen the project plans, timelines, or proposed routing.
- No compensation for trees lost is being considered by BC Hydro despite requests from staff and political representatives.
- A rooting technology was presented as an alternative. This idea was not accepted.
- 3 different timelines have been communicated.
- The Mayor has requested a letter be sent from the Natural Areas, Parks, and Trails (NAPT) committee. This will allow for his signature and a record on file.
- Prospect Lake Rd. will not be widened by Saanich. Site lines and safety are the main concern.
- An increase in hydro consumption due to electric vehicles, secondary suites and larger homes is an explanation for the project.
- The staff have not received an Environmental Impact Assessment.
- An open house with BC Hydro has been requested by the community.
- The housing targets take into consideration rural and environmental impacts.

The recommendation in the October 24, 2023, report by Councillor Brownoff was considered. The committee requested amendments which are noted in the motion below.

MOVED BY D. Marecek and Seconded by C. Du Bois: "That the Natural Areas, Parks, and Trails Advisory Committee recommend that Council send a letter to BC Hydro regarding a hydro line upgrade along Prospect Lake Road requesting the following:

- a clear rationale and supporting evidence for the project;
- a project plan with timelines;
- compensation to Saanich for tree losses;
- a fulsome environmental impact assessment;
- mitigation to Saanich for environmental impacts (based on a fulsome environmental impact assessment) with a focus on ecological restoration;
- collaboration by BC Hydro with the community along Prospect Lake Road; and
- explore development of a Protocol Agreement between BC Hydro and Saanich with respect to BC Hydro projects in Saanich that are likely to have environmental and tree-related impacts. This agreement would include processes for transparent communication, referrals, engagement, and conflict resolution with Saanich and the community as well as decisionmaking timelines.

#### DRAFT UPDATED ACTIVE TRANSPORTATION PLAN UPDATE

The Senior Transportation Planner gave a presentation (PowerPoint on file), and the following was noted:

- The updated Active Transportation Plan (ATP) document reflects current policies, incorporates up-to-date travel data, reviews, and updates infrastructure priorities for the next 15 years. This will create a framework for future traffic calming policies and address emerging technologies.
- Council adopted the first ATP in 2018 and a commitment was made to update the plan every 5 years.
- The update has been presented to Committees and will be considered by Council in December 2023.
- The feedback that was given in the Spring through online surveys, open houses, and popups events, has been collected and integrated in the update.
- 70% of the public responders support the Vision Statement.
- The Saanich Climate Action Plan lists transportation as one of the key action areas in reducing greenhouse gas emissions in the community.
- The updated goals have been well accepted and supported.
- Expanding and enhancing the trail network has been updated with definitions and actions.
- Timeframe, method, responsibility, and goals guide the implementation of strategies and actions.
- The criteria for prioritization were clarified to include trails.
- Stakeholders have requested a more thorough and complete list of projects and timelines.
- Prioritization is based on feedback received from the surveys and staff input.
- Sidewalk, Cycling and Trail network maps are new to the plan.

The committee made the following comments:

- The new 40 km speed limit may be difficult to enforce.
- Local destinations could offer safe parking and storage for bikes.

- The new protected bike lanes are narrow and difficult to pass other riders. Gaps have been added for this purpose. Future plans are for wider lanes.
- Bicycle parking for new developments could have more guidance. The existing developments do not have a mechanism to adjust parking issues. In the ATP there is a program to assist in upgrading the bike storage.
- The terminology used for the different timelines may be confusing.
- There is no policy in the document to allow businesses to park on residential roads.
- It is appreciated that maps show future plans for residents.
- The trails are shown as a base layer on all the mapping.
- A way to categorize the trails would be helpful.
- Grants could allow for faster timelines.
- Future developments will have guidelines for bike parking.
- Tillicum Rd. could use more area for the safe passage of emergency vehicles.

MOVED by D. Little and Seconded by C. Du Bois: "That the Natural Areas, Parks and Trails Advisory Committee supports the Final Draft Active Transportation Plan with minor updates to the mapping, which are currently underway."

#### RECOMMENDATION

That the Natural Areas, Parks and Trails Advisory Committee (NAPT) support the request to name Softball Diamond #2 at Rosedale Park, "Wes Jantzen and Pam Schon Field", in honour of Wes Jantzen and Pam Schon.

#### **PURPOSE**

The purpose of this report is to bring forward a field naming request to NAPT for review. The request to name Softball Diamond #2 in Rosedale Park to "Wes Jantzen and Pam Schon Field" was initiated on behalf of the Strawberry Vale Fastball Association, the Home User Group at Rosedale Park. In addition to the letter of request, there are three letters of support accompanying the proposal.

The process being undertaken is consistent with the Council Policy, "Parks Naming Policy", specifically under section 2:

"Significant features within a park may be named separately based on a recommendation from a community organization, reviewed by the Parks, Trails and Recreation Advisory Committee, and approved by Council."

NAPT is considered the successor advisory committee to the Parks, Trails, and Recreation Advisory Committee.

#### **BACKGROUND**

Rosedale Park is home to the Strawberry Vale Minor Fastball Association (SVFA), which provides fastball opportunities for youth.

Saanich has a number of sports fields named after individuals, including Diamond #1 at Rosedale Park, which was named the Rae Patterson Field in 1984, "Dedicated in Memory of his inspirational contributions to the community and to the Strawberry Vale Softball Association".

#### DISCUSSION

As members of the SVFA for 26 years, Wes Jantzen and Pam Schon have undertaken the volunteer roles of President, Director-at-Large, Umpire Coordinator, Tournament Coordinator, Concession Manager, Uniform Manager, Learn to Play Coordinator, Victoria Women's Fastball League liaison, Field Crew Member, and Groundskeeper. For the past 6 years, Wes and Pam have undertaken all these duties simultaneously.

In 2017, Wes Jantzen was awarded the Softball BC Volunteer Award for outstanding service to the softball community, followed by the SVFA being nominated for Softball BC's Best Small Association in 2018.

Due to a recent health diagnosis, Wes Jantzen and Pam Schon have had to step down from their positions with the SVFA immediately.

A report is scheduled to go to Saanich Council on January 22, 2024, for decision. This request is time sensitive due to the community member's health concerns.

#### FINANCIAL IMPLICATIONS

There are no financial implications for supporting this recommendation.

#### OFFICIAL COMMUNITY PLAN IMPLICATIONS

This request supports the following in the Proposed Official Community Plan (2023):

- 7.2.9 Support improvements to neighbourhood and community parks, beaches, and community/recreation facilities to reinforce their role as local gathering spaces and focal points in the community.

I am making this proposal as a long-time member of Strawberry Vale Fastball Association, and am the incoming President. This proposal is being made with the support of the current executive.

Rosedale Park, the home of Strawberry Vale Fastball, is a place where I have spent 24 years of my life and countless hours enjoying the sport I love - first as a minor player, then as part of the women's league, and most recently as a minor team coach and manager for the past 10 years. When I think of visiting Rosedale Park for any softball event, I think of Wes Jantzen and Pam Schon. As members and leaders of the association for the past 26 years, I cannot think of a time when I have been at the field without seeing Wes and Pam – organizing teams, coordinating umpires, running tournaments, operating the concession, and always cheering loud, showing their unwavering support. 
