WASHROOM OPERATIONS AND CAPITAL PLAN

The Manager, Park Planning and Development and Park Planner Designer gave a presentation on the Washroom Operations and Capital Plan (PowerPoint on file). The following was noted in response to questions and during committee discussion:

• Pavement provides better accessibility to washrooms than permeable surfaces.

PANAMA FLATS CONCEPT PLAN

The Manager, Park Planning and Development and Park Planner Designer gave a presentation on the Panama Flats Concept Plan (PowerPoint on file). The following was noted in response to questions and during committee discussion:

- Staff have engaged with the WSANEC Leadership Council (WLC), who are interested in participating in the process.
- Birds perceive both leashed and unleashed dogs as threats.
- At the June open house, some residents may not have received survey forms, and some were unable to use the provided QR codes.
- Engagement strategies include multiple community touchpoints; staff review data broadly and look for anomalies.
- Staff continually adjust methods to ensure resident feedback is effectively captured.
- Each fenced off-leash dog facility under People, Pets, and Parks will consider shade in its design.
- Dog-related planning reflects both site preservation and opportunities for people to spend time with their dogs.
- The park includes multiple zone designations and P-4 zoning does not prevent restoration work.
- Zoning is not linked to Saanich's Animal Bylaw; rezoning the Flats to P-5 would not restrict dog access.
- Staff have consulted with Peninsula Streams Society and Colquitz Coalition, who expressed strong interest in the stream.
- This is an update to the 2014 Panama Flats Plan, not a replacement.
- Engineering is preparing the Colquitz Integrated Stormwater Management Plan.
- There may be future opportunities to enhance the on-site fish pond.
- Most new trails would follow existing alignments.

COMMUNITY FEEDBACK ON PANAMA FLATS CONCEPT PLAN

The President of the Carey Area Residents Association, together with committee members representing environmental groups, delivered a verbal presentation and the following was noted:

- An open house was held on the future of Panama Flats.
- The majority of participants identified trails and biodiversity conservation as priorities.
- Year-round access to a rough trail is considered important.
- Protecting and restoring biodiversity and managing invasive species is a priority.
- A balance is needed regarding dog access, including on-leash and off-leash use.

- A P-5 zoning designation may be beneficial for the park.
- Maintaining the natural beauty of Panama Flats is a community priority.
- Some groups expressed concern about leash-optional access after 9 p.m.
- Removing the berm in the middle of the Flats could improve water connectivity.
- Better connection between the duck pond and Colquitz River may increase productivity.
- A costed implementation plan would be valuable.

The Manager Community Development/Business Systems exited the meeting at 5:43 p.m.

The following was noted in response to questions and during committee discussion:

- The engagement process is a strong example of community feedback, with multiple touchpoints.
- Trails and biodiversity conservation are also priorities for Parks staff.
- Fencing needs will vary by location; some areas may not require fencing, while dense blackberry growth may influence where and what type is used.
- Interim trail work is dependent on budget while Engineering develops the Stormwater Management Plan.
- Additional information on the effectiveness of signage and maps would be helpful.

MOVED by K. Humphrey and Seconded by K. Woodruff: "That the Natural Areas, Parks, and Trails Advisory Committee endorse the Panama Flats Concept Plan in principle."

The following discussion ensued:

• Endorsing the concept plan in principle means endorsing it as presented, with the understanding that it is a concept plan.
