PROJECT: DISTRICT OF SAANICH GOVERNANCE REVIEW (2015-16)

This report is an update to the Communications and Engagement Roadmap on Council's agenda on June 15th. At that time Council directed staff to revise the Roadmap in light of Council's discussion and comments offered by members of the public.

The updated Roadmap identifies:

- The goal, principles, and topic areas for discussion;
- What and when information and educational materials will be communicated to various audiences; and
- Four alternative engagement approaches.

While the overall goal and principles remain essentially unchanged, several aspects have been strengthened and augmented. Most importantly, this update sets out **four alternatives** for engagement, along with Order of Magnitude costs. Each of these alternatives is discussed in more depth later in the report; all would involve retaining a consultant as a facilitator and logistics coordinator.

Regardless of which alternative is selected, the District may choose to establish a Public Engagement Advisory Group to give guidance to staff and the consultant in relation to the communications and engagement process. Participants would be identified through a publicly advertised notice and selected by senior management.

 An enriched engagement process, which would include a number of additional café-style conversations with community associations and other Saanich-based stakeholder groups.



- 2. The same enriched engagement process as #1, plus a closing "symposium" in lieu of an "open house".
- 3. Search Symposiums, wherein the group offers suggestions on the topics to be discussed, ranks the preferred topics, then breaks into small groups to come up with recommendations.
- 4. Residents Assembly / Forum, which meets regularly over 6-8 months to discuss and make recommendations.

BROAD SCOPE OF PROJECT

Regardless of what approach Council selects for engagement the engagement component, there would four phases over the period October 2015 to September 2016;

- 1. Phase 1: October-December, Raise awareness of project – traditional and social media Prepare educational materials
- 2. Phase 2: February-June, 2016 Engage residents, stakeholder groups, Saanich staff
- 3. Phase 3: Prepar report for Council, Summer 2016
- 4. Phase 4: Council review

OVERALL GOAL AND PRINCIPLES

To ensure that Saanich residents, Saanich-based stakeholder groups, District committees and staff are informed about the Governance Review Initiative, and provided with opportunities to actively engage in identifying and prioritizing ways and means to optimize local governance. This review will be undertaken within the context of the following principles1:

- Legitimate sphere of influence legal and constitutional authority to make decisions;
- Inclusive participation all residents and stakeholders have a voice in decision-making, either directly or through an elected body (Council);
- **Consensus-oriented** Council mediates among differing interests to reach a broad consensus on what is in the best interests of Saanich's residents and stakeholders;
- the best use of resources;



Effective and efficient – producing results that meet needs while making

- Accountable decision makers are accountable to the public and institutional stakeholders; and
- Transparent processes, programs and information are directly accessible to those concerned with them, and enough information to understand and monitor them.

OVERALL APPROACH

A neutral third-party will be engaged to conduct the process, with assistance from Saanich's senior staff. The overall approach will be three-fold:

- Providing accurate, regular information about the Governance Review Initiative using a range of communications tools. All materials – whether in print or online format – will adhere to the Graphic Standards of the District of Saanich; and
- Preparing a series of educational materials related to the following four topics:
 - The role and powers of local government (municipalities and regional districts);
 - How the District interacts and communicates with residents and Saanich-based stakeholders;
 - How the District is governed internally; and
 - What is the District's relationships with its sister municipalities and the CRD, and should this be changed, to achieve more cost savings and efficiencies?
- Providing a number of opportunities for resident and Saanich-based stakeholder groups, Saanich Committees, and staff engagement throughout the project. The ideas, preferences, and recommendations contributed by all participants are documented and seriously considered by decision-makers.

KEY MESSAGES

The key messages to convey to residents and stakeholder groups are:

- In November 2014, 88% of Saanich voters approved a non-binding question to have a government review initiated by the District of Saanich.
 In light of this governance response, Saanich Council will be taking a Governance Review Initiative.
- The District of Saanich is undertaking a Governance Review Initiative to:
 - Understand how well the District, its sister municipalities, and the CRD are currently meeting the community's needs;



- Identify issues and gaps in the District's current governance model; and
- Identify strategies to optimize the District's governance in terms of four topic areas:
 - The role and powers of local government (municipalities and regional districts);
 - How the District interacts and communicates with residents and Saanich-based stakeholders;
 - How the District is governed internally; and
 - What is the District's relationships with its sister municipalities and the CRD, and should this be changed, to achieve more cost savings and efficiencies?
- The Governance Review Initiative will begin in September 2015, and take approximately one year to complete. There will be several opportunities to participate in the Governance Review Initiative.
