  - Adding context and building connective tissue around the Task Force recommendations
  - Integration of Council and community input
  - o Integration of community and stakeholder input
  - Integration of Staff input
  - o Implementation/evaluation/monitoring/demand estimates

- o Drafting the Housing Strategy Table of Contents:
  - Introduction
    - Context, Purpose, Principles, Focus Areas, Roles, Process, Alignment with other plans this may change after tonight's discussion.
  - Housing Needs Assessment
  - Focus Areas, strategies and actions
  - Implementation and monitoring
  - Appendix: definitions
- Council will consider the Housing Strategy
  - Targeting a June Council meeting
  - Share the public engagement results
  - Seeking endorsement of the Final Housing Strategy
- Implementation of the Actions
  - Select high priority actions that are targeted for the first three years
  - Resources allocated through the Strategic Plan and budgeting process will dictate how quickly actions are addressed
  - Monitoring and evaluation track progress with regular review, updates and refinements
  - Housing Needs Report required to update every five years
