1248 BURNSIDE ROAD WEST (STRANTON LODGE)

The President stated:

- The Consultant has completed the development of the Building Condition Assessment (BCA) for Stranton Lodge and 60% on the Heritage Conservation Plan (HCP).
- The BCA for Dodd House has been completed and 60% of the HCP has been completed.
- She has started to get quotes from contractors to undertake the restoration work on Stranton Lodge identified in the BCA such as stucco cleaning, wood repairs on doors and windows, painting, etc.

The Planner stated:

- It is important for the Parks Department and Lands Department to have the opportunity to review the Heritage Conservation Plans for both Dodd House and Stranton Lodge.
- It is also an opportunity to educate the departments responsible for managing the various Saanich owned properties about the purpose and value of the BCA, HCP and Statement of Significance (SOS) documents.

4139 LAMBRICK WAY (DODD HOUSE) - UPDATE

S. Colwill stated:

- Trevor with Arbor Renovations will be starting the exterior painting in June when the weather is warmer.
- She received an email from the tenant with some information regarding liability insurance for renters with respect to pets, specifically dogs, and how some policies cover accidents such as injuries from dog bites.
- Her son would like to have a dog. If they were permitted to get a dog, it would be a gentle
 breed and they could set parameters about taking it outside on a leash and not leave it
 unattended in the fenced yard.
- She would be willing to pay for legal advice and get the necessary liability insurance.
- Several years ago, the tenant asked if she could have a cat and Foundation members agreed to allow it.

Committee discussion noted:

- The most important thing is the preservation of the heritage features of the dwelling.
- If a dog was permitted it would have to be a small breed.
- It costs about \$2,000 to sand and refinish hardwood floors. If the Foundation allowed the tenants to have a dog, it could insist on a \$2,000 damage deposit.
- Fir floors have a tendency to be a softer hardwood and they been refinished once before.
 Claws can be damaging to hardwood floors and window sills.
- At some point the Lands Department will be taking over managing all of the tenancy agreements for Saanich owned properties. It may be a good idea to get their opinion on pets.

Based on the discussion around the pros and cons about allowing a dog, only one member supported it. S. Colwill will let the tenant know that a dog is not supported at this time.

- The ACH also had a presentation from the Senior Planner (Community Planning) on the draft Cordova Bay Local Area Plan (LAP) which recognizes the heritage properties located in that area. The draft document is available on the Saanich website.
- The next ACH meeting is May 26, 2021.
