4 Heritage Tracker Status Updates

• 4512 West Saanich Road (original Municipal Hall/Med Grill)

- Application for de-registration and demolition has now been submitted by applicant to Saanich.
 - Three memorials to be installed as part of redevelopment, locations have been slightly adjusted since concept originally presented to SHF.
 - Size of memorials and layout/design has not yet been confirmed. Design will be provided to SHF for comment once drafted.
- SHF provided formal written feedback to Saanich Planning on March 24, 2025 on updated application
- o Saanich staff not preparing a Report to Council

• 794 Burnside Road W

- Revised redevelopment application for heritage registered building received by Saanich
- SHF provided formal written feedback to Saanich Planning on March 24, 2025 on revised application
- Saanich staff are currently reviewing internal referrals received through circulation, which closed late April 2025.

• 3601 Craigmillar Ave

- Designation application submitted to Saanich on Sept 26, 2024.
 Includes both interior and exterior features
- Saanich Planning indicated that the application has since been put on hold by the applicant - no change

• 3830 Hobbs Street

 Application for de-registration has been received by Saanich Planning on December 11, 2024.

8 2025 House Grants

- Applications intake closed April 30. Four applications were received, and reviewed by the board.
- Applications were individually evaluated and approved. Jennifer abstained from voting on 3710 Craigmillar Ave due to conflict of interest, and Joan abstained from voting on 2144 Wenman Drive due to conflict of interest.
- Grant application for 4516 West Saanich Road was conditionally approved pending submission of additional information to confirm grant amounts:
 - o Gutter repair project only included one quote, not two as required
 - Painting project is for remaining two sides of the building (the first two sides were approved in the 2024 grant application), however only one new quote for 2025 was provided. The second quote appears to be the same as last year.
 - ACTION: Jennifer to respond to homeowner re missing quote information/clarification
- Grant application for 1140 Tattersall Drive included multiple projects, which collectively are greater than the maximum grant available. It is not clear which project the homeowner would like the grant applied to
 - ACTION: Jennifer to respond to homeowner and clarify which project is to be associated with the grant, prior to issuing grant approval letter (confirmed to be storm windows via email prior to issuing minutes)
