<p>I declare that I meet the following requirements to be registered as an elector:</p> <ul style="list-style-type: none"> (a) I am a Canadian citizen; (b) I will be 18 years of age or older on general voting day for the election; (c) I have been a resident of British Columbia for at least 6 months immediately before today; (d) I have been a registered owner of real property in the District of Saanich for at least 30 days immediately before today; (e) I am not holding the property in trust for a corporation or any another trust; (f) I am not entitled to register as a resident elector in the District of Saanich; (g) I have not registered as a non-resident property elector in relation to any other parcel of real property in the District of Saanich; and (h) I am not disqualified under the <i>Local Government Act</i> or any other enactment from voting in an election or am not otherwise disqualified by law; <p><i>If there is more than one individual who is the registered owner of the real property:</i></p> <ul style="list-style-type: none"> (i) I have received the written consent of the majority of individuals registered as owners of the real property (including me) to be registered as the non-resident property elector for this property.
