ELECTOR ORGANIZATIONS – ENDORSING CANDIDATES

The following is provided as information. It does not provide detailed information or rules related to the *Local Elections Campaign Financing Act* (LECFA).

OVERVIEW

An elector organization may endorse a candidate in an election and have that endorsement included on the ballot. The elector organization may express how they want their name to appear on the ballot (name, abbreviation or acronym).

An elector organization may endorse more than one candidate; however a candidate can only have the endorsement of one elector organization on the ballot.

To be qualified to endorse a candidate, the organization's authorized principal official must make a solemn declaration that the organization's membership includes at least 50 electors of the municipality.

A candidate must not consent to endorsement by more than one organization in an election for the same office.

IMPORTANT! If a candidate wants an elector organization endorsement to appear on the ballot, this must be indicated in the endorsement documents

ENDORSEMENT DOCUMENTS (forms)

The endorsement documents required to be completed by the organization are listed on EI-Elector Organization Cover Sheet and Checklist form.

Elector Organizations must submit the endorsement documents along with <u>all of the other required information</u>, to the Chief Election Officer before the end of the nomination period. (The statutory period for receiving the nomination documents begins at 9:00 a.m. on Tuesday, August 8, 2017 and ends at 4:00 p.m. on Friday, August 18, 2017.

If the information and materials are not received by the Chief Election Officer before the end of the nomination period, the endorsement documents cannot be accepted for filing.

Endorsement documents may be delivered by hand, mail, or courier, to the Legislative Services Division, District of Saanich, 770 Vernon Avenue, Saanich, BC, V8X 2W7.

If there is any change to the information or materials, the organization must provide updated information to the Chief Election Officer if the change happens before the end of general voting day (September 23, 2017) or to Elections BC if the change occurs after general voting day.

Elections BC

As endorsement documents and required information are received, the documents and any updated information respecting any of these documents, will be sent directly to Elections BC.

Public Access:

The endorsement documents and declaration of elector organization will be available for public inspection at the Saanich Municipal Hall, Legislative Services Division. Elections BC is responsible for providing public access to the documents obtained from the elector organization.

IMPORTANT! The information must be received before the end of the nomination period or the endorsement documents cannot be accepted for filing.

IMPORTANT! Just like the Nomination Paper, you must sign the declaration in front of a lawyer, a notary, a Commissioner for Taking Affidavits for British Columbia, or an Election Official at the time of filing the Nomination Paper

"Challenge of Endorsement"

A challenge of endorsement of a candidate may only be made by an elector of Saanich, a person nominated as a candidate in the same election or in another election being held at the same time for the same municipality, or the Chief Election Officer (from the time the endorsement is filed until 4:00 p.m. August 22, 2017 being the 4th day after the end of nomination period.)

"Withdrawal of Endorsement"

If a candidate withdraws their consent to the endorsement, they must deliver a signed withdrawal to the Chief Election Officer before 4:00 p.m. on August 25, 2017.

If an elector organization withdraws its endorsement of the candidate, it must deliver a written withdrawal signed by the authorized principal official, to the Chief Election Officer before 4:00 p.m. on August 25, 2017.
