1. The Owners, Strata Lots 1 to 260 inclusive and common property, Section 11, Victoria District, Strata Plan 845 (Phase I, II and III), a strata corporation being the registered owners of those certain lands included in Strata Plan 845 which are subject to a certain land use contract entered into between the Corporation of the District of Saanich and John Adams Traunweiser and Traunweiser Motels Ltd. on the 30th day of November, 1976 and registered in the Victoria Land Title Office under F19190 (herein called "the Land Use Contract") has applied to the Council for an amendment to the Land Use Contract.
2. The purpose of this development variance permit is to amend the Land Use Contract.
3. The Land Use Contract is hereby amended by adding thereto the plan prepared by Eric J. Barker called "Parking Plan B - Cedar Shores" a copy of which is attached hereto and by requiring that portion of the subject lands shown on the said plan to be developed with parking, landscaping, and other surface improvements strictly as shown on the said plan in place of the improvements shown on Drawings A-2, A-3, and A-10 of Schedule A of the Land Use Contract.
