Notice of a Temporary Use Permit and a Zoning Bylaw

NOTICE IS HEREBY GIVEN that a COUNCIL MEETING will be held in the SAANICH MUNICIPAL HALL COUNCIL CHAMBERS, 770 Vernon Avenue, Victoria, BC, V8X 2W7, on **MONDAY, SEPTEMBER 25, 2023, at 7:00 P.M.**, to allow the public to make verbal or written representation to Council with respect to the following proposed permit.

A. TEMPORARY USE PERMIT APPLICATION ON WALEMA AVENUE

The intent of this application is for a Temporary Use Permit for up to two years to permit the sale of homegrown and value-added fruits, flowers, vegetables, and homemade crafts at a roadside stand at Lot 7, Block 1, Section 32, Lake District, Plan 1196-A (**1013 WALEMA AVENUE**).

NOTICE IS HEREBY GIVEN that pursuant to Section 464(2) of the *Local Government Act*, as amended by the *Municipal Affairs Statutes Amendment Act (No. 2), 2021*, the District of Saanich **will not be holding** a public hearing in relation to the following proposed Zoning Bylaw Amendment.

B. ZONING BYLAW, 2003, AMENDMENT BYLAW, 2023, NO. 9919 ADAPTABLE HOUSING REQUIREMENTS

The intent of this proposed housekeeping amendment to Zoning Bylaw, 2003 is to remove the Adaptable Housing Requirements (Schedule F) and defer all requirements to the standards identified in the British Columbia Building Code.

The proposed permit and bylaw may be inspected, and further information may be obtained from the Legislative Services Division, Saanich Municipal Hall, 770 Vernon Avenue from September 14, 2023, onwards.
