## A. ZONING BYLAW, 2003, AMENDMENT BYLAW, 2023, NO. 9873 PROPOSED NEW C-6UD (UPTOWN DOUGLAS HIGHWAY COMMERCIAL) ZONE; AND PROPOSED REZONING OF VARIOUS PROPERTIES IN THE UPTOWN DOUGLAS CORRIDOR TO C-6UD (UPTOWN DOUGLAS HIGHWAY COMMERCIAL) ZONE

The intent of this proposed bylaw is to create a new C-6UD (Uptown Douglas Highway Commercial) Zone, whereby sites that do not currently have an existing automobile, boat, truck and trailer sales, rentals, maintenance, repair, and storage use would have this use prohibited from their property. This bylaw also proposes to rezone various properties within the Uptown Douglas Corridor from the C-6DE (Douglas East Highway Commercial) Zone to the new C-6UD (Uptown Douglas Highway Commercial) Zone, as listed in Schedule "B" of the bylaw.
