### A. COUNCIL PROCEDURE BYLAW, 2021, AMENDMENT BYLAW, 2025, NO. 10172

The intent of this proposed bylaw is to amend the Council Procedure Bylaw to clarify processes for conducting electronic meetings and reflect changes previously directed by Council:

- Add the definitions for "Electronic Meeting" and "Electronic Participation".
- Amend requirements for time, place and adjournment of meetings.
- Amend requirements for notice of electronic meetings.
- Amend requirements for electronic meeting procedures.
- Amend requirements for conduct and debate.
- Amend requirements for the Order and Scheduling of Business for Council meetings.
- Amend requirements for Public Input during Council meetings and Public Hearings.
