ELECTOR REGISTRATION AT THE VOTING PLACE - IDENTIFICATION WILL BE REQUIRED

Resident Electors

In order to be eligible to vote in General Local Elections as a resident, a person must:

- Be 18 years of age or older when they register to vote or 18 years or older on General Voting Day; and
- Be a Canadian citizen; and
- Have been a resident of BC for at least six months immediately before they register to vote; and
- Be a resident of the District of Saanich; and
- Not be disqualified under the *Local Government Act*, or any other enactment from voting in local elections or be otherwise disqualified by law.

To register, resident electors will be required to produce **2 pieces of identification** (at least one with a signature). Picture identification is not necessary. The identification must prove both residency and identity.

Non-Resident Property Electors:

A non-resident property elector must:

- Be 18 years of age or older when they register to vote or 18 years or older on General Voting Day; and
- Be a Canadian citizen; and
- Have been a resident of BC for at least six months immediately before they register to vote; and
- Be the registered owner of real property in the jurisdiction where they intend to vote for at least 30 days immediately before they register to vote; and
- Not be disqualified under the *Local Government Act*, or any other enactment from voting in local elections or be otherwise disqualified by law.

To register, non-resident property electors must produce **2 pieces of identification** (at least one with a signature) to prove identity and **proof** that they are eligible to vote in relation to the property. Only one person is eligible to vote as the non-resident property elector for that property when a person owns a property with one or more other individuals. The owner entitled to vote must be designated, in writing, by the majority of the property owners.

MAIL BALLOT VOTING

Mail ballot voting is available to all qualified Saanich electors.

Applications to receive a mail ballot will be accepted until 4 p.m., Thursday, October 15, 2026. Mail ballots will become available on or about October 1, 2026. It is the responsibility of the elector to ensure the ballot is returned to the Chief Election Officer, Saanich Municipal Hall, before the close of voting at 8 p.m., Saturday, October 17, 2026.
