Spring update from Mayor Haynes

While we are working hard to effectively address COVID-19, Mayor, Council and staff are also working to evolve Saanich culture. At the March 2 Council meeting, the staff report with 42 items of improved service efficiency involving each of our major departments was received and welcomed by Council.

In our Planning Department, the building permit application process has been reorganized to include a new plan checker position. Centralization of the plan review function will aid customer service, and the promotion of cross-departmental communications will improve timely service delivery and plan reviews will improve delivery of building inspection services.

The Occupational Health and Safety Division completed a review of WorkSafeBC decisions pertaining to relief of cost. Reviews of previous decisions has resulted in several savings: the removal of more than \$125,000 of claims costs; a \$97,000 refund on prior and current years' premiums; and mitigation of the increase in Saanich's 2020 premiums by roughly \$45,000. Over in Engineering's Solid Waste Services, in order to improve customer service and operational cost savings, overhauls of our annual leaf collection program have been made.

A second report on March 2 proposed changes to scheduling Council meetings. One difference is focusing public consultation from Committee of the Whole meetings to Public Hearings. This change provides the public with the opportunity to give their opinion through early engagement and addressing Council at Public Hearings. This will help streamline our development process immensely!

A big thank you to staff for bringing these reports forward and helping to make Saanich ever more efficient, responsive, valuable and cost-efficient to our citizens.

COVID-19 information

The District of Saanich is prepared to handle potential impacts and service disruptions from COVID-19.

As the situation unfolds, we will continue to monitor credible sources and will work with our provincial and regional partners. It's important to note that Saanich is not the lead agency on COVID-19; we will take direction from the Province and the Medical Health Office.

As of March 6, we took the proactive approach to activate our Emergency Operations Centre (EOC) before any impacts occur in Saanich. At this stage, the role of the EOC is to assist with planning efforts and sharing information.

We encourage residents to visit saanich.ca/covid-19 as well as our corporate social media accounts (Facebook and Twitter) for the most up to date information about service disruptions.

Prevention

The BC Centre for Disease Control and the World Health Organization report that hand washing if the most effective way to stop the spread of COVID-19.

A reminder to our staff and residents:

- wash your hands often with soap and water for at least 20 seconds;
- · avoid touching your eyes, nose or mouth, especially with unwashed hands;
- · avoid close contact with people who are sick;
- · cough and sneeze into a tissue or your sleeve and not your hands;
- stay home if you are sick, especially if you are experiencing COVID-19 symptoms, to avoid spreading the illness to others; and
- practice social distancing (e.g., keeping a two metre distance and avoid touching others).

As a preventative measure, we are reviewing and adjusting our cleaning protocols. High contact surfaces will receive more frequent cleaning in all municipal facilities.

New budget education tool

Council's deliberations on the <u>draft 2020-</u> 2024 Financial Plan are well underway, but there's still time to participate!

As part of the 2020 budget process, Saanich launched a new online <u>budget education</u> tool. The tool provides an opportunity for citizens to learn about the financial planning process while Council deliberates the draft plan. The real-time results allow residents to see how budget changes could impact their property taxes.

The tool is available to explore until April 3, 2020 at **saanich.ca/budget**.

Council must adopt the Financial Plan and Tax Rate Bylaws by May 15, 2020. Property taxes are due July 2, 2020.

Six municipalities partner on child care analysis

Saanich has partnered with the municipalities of North Saanich, Central Saanich, Highlands, Oak Bay and Sidney to develop a community child care inventory and gap analysis.

"I'm delighted the six mayors and councils on the peninsula from Oak Bay to North Saanich have combined resources for a collaborative approach to deliver results for our residents through this important analysis," said Mayor Fred Haynes. "We all hear from young families in our communities that the chronic shortage of child care causes significant problems and negatively affects their quality of life. We aim to improve child care services across the region reducing stress on families and the economy."

The six municipalities hired <u>Queenswood</u> <u>Consulting Group</u> to lead a series of workshops and public engagement opportunities to gather information about existing childcare resources in the region. Queenswood will work with direct child care providers and families to understand the challenges and opportunities of providing services.

The following types of child care services will be included in the analysis:

- Group child care (under 36 months to school age)
- Group child care (school age including after school or school closure care)
- Preschool
- Family child care
- Occasional child care
- Multi-age child care
- In-home multi-age care
- Child-minding

The analysis will establish an inventory of existing services and a dynamic action plan aimed at enhancing and expanding services to families in each of the six municipalities. The action plan will recommend ways to provide more daycare spaces in order to reduce travel time for families. Each municipality will support the recommendations in a way that is responsive and sustainable for their community.

The six municipalities received a \$150,000 grant through the Union of British Columbia Municipalities (UBCM) Community Child Care Planning Program to conduct the analysis. The analysis is expected to wrap up with a final report and action plan by November 2020.

New electric zamboni at G.R. Pearkes

G.R. Pearkes recreation Centre recently received delivery of our brand new electric zamboni. This zamboni replaces our propane powered Ice Resurfacer and will be used to clean the ice in the Green and Gold Arenas.

Both the staff and community are excited to have this new "toy" in action. This machine replaces an older unit that was beginning to impact community ice use with its repair, maintenance and downtime.

We estimate our Zamboni fleet drives the equal distance of Victoria to Halifax each year. The shift from propane to electric power will save 5.7 tonnes of greenhouse gas (GHG) emissions per year. This is on top of the 36 tonnes of GHG we anticipate to save with the REALice upgrade that was completed in December.

Please follow our simple petiquette. It's as easy as 1,2,3:

- 1. Pick up after your dog
- 2. Obey leash regulations
- 3. Be mindful of the environment

There are no designated dog parks in Saanich, however only six of our 170 parks have any restrictions on dogs. All other Saanich parks allow dogs that are on leash or under effective control.

Seasonal dog restrictions

....

From May 1 to August 1 dogs are not permitted in:

- Cadboro-Gyro Park or the Cadboro Bay public beach area in front of the park and towards Oak Bay after 9 a.m.
- Cordova Bay Beach after 9 a.m.
- Mount Douglas Park Beach and adjacent picnic/parking area
- Whitehead Park

From March 1 to October 31 dogs are not permitted in fenced baseball fields.

All-year dog restrictions include:

- Swan Lake Christmas Hill Nature Sanctuary
- Quick's Bottom Park
- Artificial turf fields
- · Rithet's Bog other than leashed on the perimeter trail
- Within 50 metres of King's Pond in Cedar Hill Park except leashed on the chip trail

Dog must be on a leash:

- on school grounds
- within 10 metres of playground equipment
- in the Royal Oak Burial Park
- on the Lochside Trail within the Blenkinsop Lake area
- in Cedar Hill Park, including all trails
- · along the perimeter trail in Rithet's Bog
