

Murals & Wall Signs

A mural is artwork painted or applied directly on a wall or other large permanent surface and typically covers the whole wall or a large portion of it. In contrast a "wall sign" painted on an exterior wall may only cover a maximum of 15% of the wall (see Sign Bylaw). A "wall sign" requires a Sign Permit.

Mural Approval

To paint or apply a mural on a building in Saanich, the design must receive Council approval or be approved through the Public Art Jury process. Saanich's Comprehensive Arts Policy outlines a Public Art Jury process for the selection of any civic public art to ensure that artwork is chosen through an equitable process and that it is of value to the neighbourhood, the arts community and the property owner. The private sector is encouraged to follow the Public Art Jury process in choosing a mural design.



District of Saanich's Bylaw No. 8417, Respecting Unsightly Premises, requires that any drawing, printing, picture, writing or mark on a surface on public lands or on private lands where the surface is visible by the public, must be approved by Council; or through a Public Art Jury process outlined in Saanich's Comprehensive Arts Policy; or through a permit pursuant to the Sign Bylaw, 2000, No. 8101.

Public Art Jury Process

- 1. Select a project jury including:
 - 3 artists;
 - 1 community member delegated through the local Community Association; and
 - 1 representative of the land owner or commissioning agency.
- 2. Prepare a project brief or terms of reference including criteria for judging.
- 3. Advertise a 'Request for Proposals' based on the project brief.
- 4. Artists submit entries.
- 5. The project Jury judges the entries and chooses a winning submission.
- 6. Submit a copy of the project brief, list of Jury members, and images of winning submission to the Saanich Planning Department.
