In consideration of Camp Imadene permitting me to use and/or operate and/or be a passenger and/or be towed by a boat and to use its docks, parking and other facilities associated with the above organization, I hereby acknowledge and agree with the above noted organization as follows:

1. that I am aware that there are many RISKS, DANGERS and HAZARDS associated with access to and the use and operation of boats and related equipment (including fishing gear), including but not limited to wet or icy conditions of docks, failure of a boat's engine and hull equipment, fire theft, sinking capsizing changing weather and sea conditions, including tides, currents, waves, rocks, floating debris, submerged debris, other vessels (including collision with other vessels or their waves) whether or not caused by the fault of negligence of other vessels or their operators or by the above noted organization or by any other person. I freely accept and fully assume all such RISKS, DANGERS and HAZARDS and also accept and fully assume the possibility of personal injury, death, property damage or loss resulting from such RISKS, DANGERS and HAZARDS.
2. to ASSUME AND ACCEPT ALL RISKS, DANGERS and HAZARDS in connection with my use of the above noted facilities and use or operation of a boat and/or participation in boat-related activities.
3. I understand that being towed by a powerboat is an inherently dangerous activity and that I ASSUME AND ACCEPT ALL RISKS, DANGERS and HAZARDS in connection with this activity.
4. to
 - a) Observe safe operating practices at all times
 - b) Observe all caution signs and other notices posted in boats or around the above noted facilities
5. to RELEASE the above noted organization from any and all liability for any loss or damage, injury or expense that I or my next of kin may suffer as a result of my use of the boat or the above noted organization's facilities, due to any cause whatsoever.
6. to WAIVE ANY AND ALL CLAIMS that I may have against the above noted company and their respective directors, officers, employees agents or representatives (who are included in the term "above noted organization" wherever used herein
7. that THIS WAIVER AGREEMENT shall be effective and binding upon my personal representatives, by next of kin, executors and administrators in the event of my death or incapacity.
8. that ANY AND ALL LEGAL DISPUTES SHALL TAKE PLACE WITHIN THE COURTS OF BRITISH COLUMBIA, CANADA

I HAVE READ AND UNDERSTOOD THIS WAIVER AGREEMENT AND CONDITIONS OF USE PRIOR TO SIGNING IT AND AM AWARE THAT BY SIGNING THIS DOCUMENT I AM AFFECTING THE LEGAL RIGHTS AND LIABILITIES OF MYSELF, MY PERSONAL REPRESENTATIVES, HEIRS, NEXT OF KIN, EXECUTORS, AND ADMINISTRATORS IN RELATION TO THE ABOVE NOTED ORGANIZATION.
